As of May 2015, 27 Officials Clinics had already been conducted. A 26% increase in National Certification among CT officials has been achieved. In addition, there has been a significant increase in activity by CSI officials at national level meets. The "Catch the Wave" annual end of year registration program improved official registrations and re-certifications. In addition, the Officials Committee is updating the CSI Officials Manual on a regular and consistent basis.

# Discussion Regarding Proposed Changes to Age Group Championships

Primarily because of deck and spectator seating and capacity issues and recent Wesleyan University restrictions and limitations, the Age Group Championship meet was recently designated as a 14 and under Championship meet.

A motion was made by GYWD Head Coach Nick Cavataro to rescind the Age Group Championship Meet format that was recently approved at the CSI Committee level for 2016 and for the General Chair to appoint a special Committee to analyze and evaluate the Short Course Age Group Championship Meet format. Discussion occurred and a roll call vote was taken on the motion. The motion to rescind the new Age Group Championship Meet format was defeated by a vote of 41 to 2.

#### Senior Committee Report

Short Course Senior Championships will be held on February 18 – 20, 2016. The format will be short course morning trials and long course evening finals. A short course Last Chance Meet will be conducted on March 17 – 20, 2016 and the meet may be held at Wesleyan University depending upon availability of the pool.

# **Meet Cancellation Sanction Fee Refund Request**

Chuck Elrick reported that a short course meet scheduled to be conducted at Hopkins pool was not held because of lack of interest. However, the meet was not cancelled. Coach Elrick requested a refund of the \$300 sanction fee which request was denied.
