**MEET TYPE:** Open Invitational Distance Meet, subject to the rules on the CT Swimming <u>Meet Management</u> page.

**MEET FORMAT:** The meet will be swum as Timed-Finals. All events will be swum fast-to-slow, mixed genders, and the 400 IM & 200 IM will alternate heats.

**SCRATCH PROCEDURES:** Scratches are preferred by Friday at 12:00pm. Late Scratches are due no later than 20 minutes before the start of the Meet.

**BEFORE ENTERING FACILITY or WHAT TO BRING:** Swimmers must arrive prepared to Race through one of the back entrance doors of the Pool where Waivers will be collected. Officials, Timers, and Coaches will adhere to these same rules.

#### **FACILITY RULES:**

Swimmers will be required to wear a face covering when not competing as well as observe 6 feet of social distancing when walking around the facility. There will be designated spaces for the next heat of swimmers to stand, as well as designated spaces for Timers. All Coaches, Officials, Timers, and other Essential Meet Staff will be required to wear a face covering at all times, no exceptions. No Spectators will be allowed.

Planned number of individuals on deck: See supporting documents (No more than 250) Planned number of individuals in spectating area: 0 (May be used for Swimmer Seating)

**FACILITY:** The Cheshire Community Pool is an 8-lane, 50-Meter pool. Water depth at start end is: 12-6 Feet. Water depth at turn end is: 4 Feet. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. There is an 8 Line Electronic Daktronic Scoreboard with Touchpads at both ends. There is NO spectator seating, the Meet will be Livestreamed.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

**SAFE SPORT POLICIES:** The Meet will be Livestreamed. A link will be sent to Coaches prior to the start of the Meet.

**DISABLED ACCESS:** The Cheshire Community Pool is handicap accessible in all facets. Please contact the Safety Chair for further accommodations.

**SESSION TIMES: Subject to Change**

**WARM-UPS:** CT Swimming Warm-Up Procedures will be in effect. Warm-Up Assignments listed by Team will be distributed by the Thursday before the Meet

**ELIGIBILITY:** All USA Swimming clubs and individuals. Athletes with Flex memberships must not have swum in more than one USA Swimming meet prior to this meet in order to be eligible.

All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete registration procedures. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck Clubs are reminded that participation of unregistered swimmers and/or coaches will result in a \$100 fine per instance, as described in CT Swimming meet policies:

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water **without the use of the backstroke ledge.** When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**ADULT ATHLETES:** All athletes who will be 18 years of age or older on any day of the meet must complete the mandatory Athlete Protection Training prior to competition. Failure to do so will result in the swimmer being scratched from the meet.

**ADAPTED SWIMMING:** Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability <u>prior</u> to competition. Adapted athletes may direct questions to the <u>Connecticut Swimming office</u>.

ENTRY OPENING DATE: Entries will be accepted no earlier than 8:00 pm on May 28, 2021.

**ENTRY LIMITATIONS:** All Athletes are limited to a maximum of 2 Events for the Meet.

**ENTRY TIMES:** Submit entry times in: LCM

**DEADLINES:** Deadline is June 7<sup>th</sup>, 2021. Mail hardcopy and payment to the entry chairperson: Dave Modzelewski, 967 South Main Street, Cheshire, CT, 06410. All entries must be legible and must use full names and registration numbers from USA Swimming registration. State how you will determine the date an entry is received (email receipt, payment receipt, etc.).

CONNECTICUT-ONLY DEADLINE: CT deadline is June 7<sup>th</sup>, 2021. Accepted Entries will be determined by timestamp on emailed entry file. CT clubs meeting this deadline will be entered before out of state clubs.

**ELECTRONIC ENTRIES:** Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at dmodzelewski@sccymca.org. Please check that your team name, address, and contact information are listed correctly in this file. Payment is due by the Start of the Meet.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

All adult athletes, or parents of minor athletes, who enter without club affiliation will be required to attest to reading and understanding the <u>Minor Athlete Abuse Prevention Policy</u>.

**ENTRY FEES:** Electronic entries: \$10.00 each for 400 Free & 400 IM events, \$7.00 for the 200 IM event. Manual entries: \$15.00 for individual events. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

**OUT-OF-STATE SWIMMER SURCHARGE:** Meet host will collect a \$5.00 per out-of-state swimmer surcharge, to be forwarded in full by the host team to CT Swimming.

**OUTREACH ENTRY FEE REIMBURSEMENT**: Participating clubs will submit payment in full to the meet host for all Outreach athlete entry fees (splash fees). These fees will be reimbursed by CSI to the participating CSI club after completion of the meet. Scratches and 'No Swims' will not be reimbursed. **PAYMENT INSTRUCTIONS**: Please make checks payable to STPA and mail to: Dave Modzelewski, 967 South Main Street, Cheshire, CT, 06410. Payment must be received by 06/11/2021.

### **CUT PROTOCOL:**

If the session is oversubscribed the following protocol will be instituted IN THE ORDER PRESENTED to reduce the timeline to the required length or participation number:

- 1. Athletes aged 7 and Under will be cut from the meet.
- 2. The distance events (400 meters or yards or greater) may be heat limited to the first 10 heats of entries <u>in</u> the order they were received, in order to fit within time constraints and Maximum Capacity restrictions.
- 3. The maximum number of events allowed per day may be reduced by one (1).
- 4. Visiting teams may be cut based on the date/time of the receipt of the final paid entry. If teams are cut, the host reserves the right to offer the available partial entry to the cut teams in the order that entries were received in order to fill the meet.

The host reserves the right to seek approval from Program Operations for additional changes, which may reasonably maximize participation opportunities.

Notification of any cuts or requests for changes must be made to Program Operations as soon as possible by the host. Attending teams will be notified no later than the Monday before the meet.

NOTE: If the host is required to institute the published cut protocol above. All accepted entries at the time that the cut protocol is instituted may be considered final by the host for the purposes of financial responsibility. (i.e. Teams submitting "placeholder" entries will be required to pay for the entries if the cut protocol is required).

**RESERVE THE RIGHT TO MAKE CHANGES:** In accordance with CSI Policies, the meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. The Meet Referee will seek Program Operations approval for all changes requiring approval. Clubs will be notified of changes no later than Monday before the meet.

**RELAYS:** No

#### **SAFETY:**

- 1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- 2. No shaving is permitted at the competition site.
- 3. No glass containers are permitted within the facility.
- 4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- 5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

**SWIMWEAR:** Per CT Swimming policy, swimmers 12 years old and younger are not permitted to wear "Tech Suits" at any CT sanctioned or approved meets. "Tech Suits" are defined as a suit that has Bonded Seams, Kinetic Tape, or Meshed Seams. Age is determined on the first date of the meet.

#### PHOTOGRAPHY AND VIDEO RECORDING:

Meet Management has the full authority to restrict any and all photography, audio and visual recording using cameras, video cameras, tablets, cell phones or other electronic devices at a meet.

Photography or video recording from the deck is prohibited by all individuals, other than participating Coaches, unless prior authorization from the Meet Referee or meet referee has been granted.

Under no circumstances is photography or video recording permitted by anyone in the area adjacent to or behind the starting blocks, including spectator stands at deck level, while they are in use for race starting purposes during competition and warm-ups. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Photography or video recording and the use of audio, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Additional "No Camera Zones" may be designated by Meet Management or the meet referee.

If individuals are properly credentialed, not obstructing movement on the deck and abiding by these rules, the following individuals may be allowed by Meet Management and the meet referee with prior authorization if they possess the following:

- Professional photographers with current, official media credentials that are promoting the sport of swimming
- Official team and professional meet photographers that are USA Swimming members, background checked, have signed off on MAAPP and completed Athlete Protection Training
- A participating athlete directly assisting a Coach, for instructional purposes, during an event using the Coach's electronic device

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

**DRONES**: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by USA Swimming Vice President of Program Operations.

**RULES:** Current USA Swimming rules will govern all competition.

**TIME TRIALS:** No

**TIMERS, OFFICIALS OR WORK ASSIGNMENTS:** Participating Teams will be notified of Work Assignments by the Wednesday before the Meet.

All volunteers will be required to attest to reading and understanding the <u>Minor Athlete Abuse Prevention</u> <u>Policy.</u>

**DECK ACCESS:** Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

**SCORING:** The meet will not be scored.

**PARKING:** All Swimmers and Essential Meet Staff will be required to park in the Cheshire Community Pool Parking Lot which is located immediately adjacent to the facility.

#### WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to BE ON PREMISES to either accompany my child or he or she conduct business, voluntarily participate in recreational events, attend practice or participate in training or compete at [Cheshire Community Pool] or any [Cheshire Y/Sea Dog Swim Club] related activity (hereinafter the "Activity" or "Activities"), I, on behalf of myself and any minor child/children for whom I have the capacity to contract, hereby acknowledge and agree to the following:

- 1. I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated, and I accept full responsibility for familiarizing myself with the most recent updates.
- 2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in Activities.
- 3. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the Activities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT SUE (on behalf of myself and any minor child/children for whom I have the capacity to contract) [Cheshire Y/Sea Dog Swim Club] and / or [Cheshire Community Pool] and its owners, officers, directors, agents, employees, and assigns (the "RELEASEES") from any liability related to COVID-19 which might occur as a result of my being on the premises and participating in the Activities.
- 4. I shall indemnify, defend, and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.
- 5. It is my express intent that this Waiver and Hold Harmless Agreement shall bind any assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENENANT NOT TO SUE the above-named RELEASEES. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT OF THE PERMISSION GRANTED BY RELEASEES TO BE ON PREMISES AND PARTICIPATE IN THE ACTIVITIES. BY SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute the Agreement for full, adequate, and complete consideration fully intending to be bound by same.

### **Cheshire Plan for Meet Participant & Spectator Ingress & Egress**

- 1) All Swimmers/Officials/Essential Meet Staff/Spectators will be given times to arrive to the Pool
- 2) All Swimmers/Officials/Essential Meet Staff/Spectators will enter through the Back Door of the Facility
- 3) Upon entering, all Swimmers/Officials/Essential Meet Staff/Spectators will be required to pass a Wellness Check consisting of a temperature check and COVID-19 Contact Tracing Questions
- 4) Upon passing the Wellness Check, all Swimmers/Officials/Essential Meet Staff/Spectators will have designated areas based on their participation needs
- 5) At the conclusion of the Meet, all Swimmer/Officials/Essential Meet Staff/Spectators will exit in the same fashion that they arrived

### **Cheshire Plan for Gathering Spaces**

- All Swimmers will be stationed around the Pool Deck and on the Bleachers
- When lining up for Races, there will be at most 1 Swimmer on the starting block, and 1 Swimmer 6 feet behind ready for the following heat, and 1 Swimmer in the water for fly-over Starts
- All Timers will be stationed in the middle of the starting blocks in between the Swimmer on the starting block and the Swimmer in the following heat
- The only people allowed consistently on the "Competition Pool Deck" are Timers, Officials, and other Essential Meet Staff
- No Spectators will be allowed in the facility, the Meet will be Livestreamed for viewing purposes
