Warm-up/Start: See Event Schedule

Entry Deadline: Friday, July 1, 2005. Connecticut teams whose entries are received by Friday, June 24, 2005 will be entered in the meet first, acceptance being determined by date/time entries are received. After that date, CT Swimming and out-of-state teams will be accepted based on date/time entries until the meet is full.

Entries: Swimmers are limited to 4 events per session. Swimmers must be registered members of USA Swimming. Age group will be determined by age as of July 9, 2005. All entries are to be submitted using LCM times. Please do not use NTs. All teams are encouraged to send entries by disk using Hy-Tek or LSA software. Please submit a paper copy of the entry along with the disk. The paper copy will be considered the official entry in the event of discrepancies. Entries submitted without electronic files will be assessed \$1.00 per swimmer. Mail all entries to the meet entry chair.

Fees: \$3.50 per event. Checks payable to Woodbridge Aquatic Club.

Awards: 9/10 and 11/12 Sessions only, Ribbons, 1st – 10th Place.

Work Assignments: Teams will be asked to supply timers in relationship to the size of their entry. Assignments are for the duration of each session. Teams providing officials will have their timing assignments adjusted. Officials from other teams are encouraged to work the meet, especially in lieu of this weekend also being CT Senior Championships.

Concessions: Available at all sessions.

Starts: Flyover starts may be used in the event of a full meet.

Meet Session Modifications : The meet manager reserves the right to modify the session schedules as published in this meet announcement, for the purpose of accommodating as many needs as possible. An example of this would be expanding one session and shrinking another if meet entries so dictate. The 4 hour rule will be adhered to for all 10/U and 11/12 sessions.

Directions: Merritt Parkway to Exit 59. Turn south to the first traffic light and left onto Whalley Ave. Go 3.7 miles to York Ave. Turn left on York to the first light. Turn left. Yale's Payne-Whitney Gymnasium is straight ahead.
