Facility: The Yale Practice Pool is a 5-lane 50-meter facility with hand held timing, limited deck space and spectator seating. Spectators should be their own chairs. The Payne Whitney Gymnasium is handicapped accessible with the use of ramps and elevators. Parking can be found near and around the gymnasium; handicapped parking can be found on Tower Parkway in front of the gym.

Events: The event will run fastest to slowest, alternating women and men. Heats may be combined. OMNI reserves the right to limit the number of heats of an event, subject to the approval of the CSI Program Operations Chair. The competition will be limited to 3 hours and 15 minutes.

Entry: Any swimmer who wishes to swim UNATTACHED must mark this clearly in red with 'UN' alongside the swimmers' name on the entry. **Teams are encouraged to submit their entries via email.** A diskette compatible for a PC using LSA Swim Team, Hy-Tek or other SDIF is also acceptable. An original paper copy of the entry must accompany all entries. Team entry date will be determined by the date the hard copy and entry fees are received. **Results will be emailed to contact person. Paper results will be sent upon request only.**

Entry Deadline: The entry deadline is **May 10, 2008.** Teams will be entered on a first-come, first-serve basis. If cuts need to be made teams will be notified no later than May 12, 2008.

Entry fee: \$7.00 per event. There will be a \$5.00 charge per swimmer for hand entries. **Make checks payable to OMNI Swim Club.**

Warm-up session - General warm-up 5:00 - 5:40 p.m. – Meet starts @ 5:45 p.m. Time permitting; there will be a 5-minute break after every other men's heat or every four heats.

Eligibility: Only 2008 USA Swimming members are eligible and must be registered prior to entry deadline. The swimmer's age as of May 16, 2008 will determine his/her age for the meet. USA Swimming will govern the meet. There are cut – off standards for this meet.

Scratches: Coaches will receive a scratch sheet in their information packets listing all of their swimmers for the event. Coaches must indicate all scratches on these sheets and turn them in to the office within 20 minutes after the beginning of warm-up.

Timers and officials: Swimmers will need to provide their own timers and counters. OMNI welcomes anyone who wishes to assist in officiating during this meet. Please contact Tim Wise.

USA Swimming membership cards: All officials and coaches must wear their USA Swimming membership cards while on deck. All Coaches must present a valid USA Swimming Coaches Card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

Awards: No awards will be distributed.

Directions: Take Exit 3 off of I - 91 (Trumbull Street). Go straight through three lights, at the fourth light take left (Prospect). At the next light take right (Grove street). Follow road through one light and Payne Whitney is straight ahead. Practice Pool is located on the third floor.
