MEET CLASSIFICATION: This meet is open to all USA Swimming athletes and clubs.
MEET FORMAT: The meet will be swum as Timed-Final.
SCRATCH PROCEDURES: The meet will be swim as timed-finals. Each session will be seeded by computer based on positive check-in at the beginning of each session. Coaches will receive a positive check-in sheet before each session which must be returned no later than 30 minutes before the beginning of each session. Heat sheets will be posted around the pool deck, distributed to coaching staffs, and will be available at the control desk.

FACILITY: Wolff-Zakin Natatorium is a 6-lane, 50 Meter pool. Water depth at start end is: 5 Feet. Water depth at turn end is: 14 Feet. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. Colorado Time Systems electronic timing and scoreboard display will be available. Spectator seating is available for 400. There is no standing along the railing and glass.

DISABLED ACCESS: Handicapped parking, handicapped entrances and pool, locker rooms and spectator areas are accessible. The Meet Director should be contacted for more information and special arrangements.

## COURSE: LCM.

SESSION TIMES: Morning: Warm-up 7:30 AM/ Meet Start 8:45 AM. Afternoon: Warm-up 1:15 PM/Meet Start 2:30 PM.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect.
ELIGIBILITY: All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete
registration procedures. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. Adapted athletes may direct questions to Mark Kinne, Adapted Athlete Committee Chair.

ENTRY LIMITATIONS: Swimmers may swim 4 events per day. Swimmers may elect to enter as many events as they wish and scratch down to 4 events per day.

ENTRY TIMES: Submit entry times in LCM.
DEADLINES: Entry deadline is May 15, 2012. Mail hardcopy and payment to the entry chairperson: John ONeill, LRAC, 3 Ridgewood Road, Cumberland, RI 02864. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. If needed, date of entry will be determined by date of receipt of payment.

CONNECTICUT-ONLY DEADLINE: CT club deadline is May 5, 2012. If needed, date of entry will be determined by date of receipt of payment. CT clubs meeting this deadline will be entered before out of state clubs.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at swimjto@gmail.com. Please check that your team name, address, and contact information are listed correctly in this file. Mail hardcopy and payment to the entry chairperson: John ONeill, LRAC, 3 Ridgewood Road, Cumberland, RI 02864. If needed, date of entry will be determined by date of receipt of payment.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: $\$ 5.00$ for individual events, $\$ 6.00$ for distance event. Manual entries: $\$ 6.00$ for individual events, $\$ 7.00$ for distance events. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

PAYMENT INSTRUCTIONS: Please make checks payable to LRAC and mail to: John ONeill, LRAC, 3 Ridgewood Road, Cumberland, RI 02864. Payment must be received by May 15, 2012.

CUT PROTOCOL for INVITATIONALS: If needed, the distance events (400M Free and 400M IM) will be cut by time to no more than 5 heats each sex. Should further cuts be necessary, teams will be cut in the reverse order of entry receipt. The Little Rhody Aquatic Club will limit the morning senior sessions to no more than 4.5 hours, and the afternoon 12/under sessions to no more than 4 hours. Clubs will be notified of changes no later than Monday before the meet. As a reminder, a Club's date of entry will be determined by date of receipt of payment.

RESERVE THE RIGHT TO MAKE CHANGES: The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of cuts no later than Monday before the meet.

RELAYS: None.

## SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. Electronic audio or visual recording devices, including cell phones, are not permitted in changing areas, rest rooms, or locker rooms.

RULES: Current USA Swimming rules will govern all competition.
TIME TRIALS: Time trials will be offered at the discretion of the meet referee if time allows. Time trials are $\$ 10.00$ for individual events. Time trial events count toward the total number of event limitations per session. Time Trial events are limited to those events published in this meet announcement.

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Swimmers in the 400's should provide their own back-up timer. Clubs will be asked to back-up time. Participating clubs will be notified of work assignments by the Monday before the meet.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.
AWARDS: None
CONCESSIONS: A basic concession will be available.
